ORDER:

The General Secretary, Anadha Vidhyarthi Griha, Hyderabad vide representation 1st read above have represented that, Anadha Vidhyarthi Griha, Hyderabad, was established in 1919 to cater to the needs of Orphan students of A.P. which provides lodging, boarding, bus pass, pocket money, college admissions etc., to the inmates. The Hyderabad Urban Development Authority, Hyderabad has allotted 2250 sq. yds of land to them for construction of Hostel Building to accommodate at least 300 Orphan students with all the facilities like parking, sports rooms, kitchen, dining, library and dormitory and finally requested to consider to sanction the plan duly exempting fees and help the Orphanage. The General Secretary has further represented that, they have submitted the building plans to Greater Hyderabad Municipal Corporation, Hyderabad for construction of building and requested the Government to sanction the plan duly exempting all the fees and help the orphanage inmates.

2. The Commissioner & Special Officer, Greater Hyderabad Municipal Corporation, Hyderabad has submitted a detailed report in the matter and informed that Anadha Vidhyarthi Griha have submitted the proposals for construction of Hostel Building consisting of 2-cellars for parking, Ground + (4) upper floors for Dormitory in plot No.2, of Chitra layout in Sy. No.13 to 15 at saroor nagar, L. B. Nagar, Hyderabad in the name of Anadha Vidhyarthi Griha. The HUDA has executed Lease deed vide Doc.No.417/07 dt: 29.01.2008 in favour of Anadha Vidyarthi Griha for a period of (25) years in Sy. No.13 to 15 measuring 2250 sq. yds. situated at Saroornagar (V) & (M). The Commissioner & Special Officer, Greater Hyderabad Municipal Corporation, Hyderabad has reported that the fees / charges have been worked out for Rs. 20,67,525/- for the proposed building.
